- First Day of School: Tuesday, September 6th | Last Day of School: Thursday, May 25th
- Second Child-Discount: A 10% discount will be offered to the sibling with the lower tuition amount.
- The Registration Fee is due at the time you sign your contract and is non-refundable/non-transferable.
- Tuition may be paid in full or in monthly installments. The monthly tuition is divided into nine equal payments and due on the 1st of each month. The first payment is due on July 1, 2021; or, if admitted mid-year, before your first day of school. The remaining payments will begin on October 1, 2022 and will continue until the last payment on May 1, 2023.
- The amount equal to two monthly tuition payments is nonrefundable/nontransferable. A 30-day written notice must be given to be released of the Day School Contract. *To be released of the tuition payment obligation, a written notice must be received by June 1, 2022 or at least 30 days prior to the stated Contract Start Date on your contract.*
- All payments are processed through the Brightwheel app, the school's online billing and communication tool. Families are responsible for on-time payments according to the Day School Contract signed at the time of enrollment. A \$50 Late Fee will be assessed for payments made after the 7th of the month. A child's enrollment may be discontinued if an account balance is more than 30-days past due.
