- Second Child-Discount: The Registration Fee will be waived for the oldest sibling.
- The Registration Fee is due at the time you sign your contract and is non-refundable/non-transferable.
- Tuition may be paid in full or in monthly installments. The annual tuition is amortized over the course of the year with nine equal payments. The first payment is due when you sign the contract. The remaining payments are due on the first day of each month, beginning on October 1, 2025 and continuing until the last payment on May 1, 2026.
- The following is owed if a family finds they need to withdraw enrollment before the end of the school year.

- All payments are processed through the Brightwheel app, the school's online billing and communication tool. Families are responsible for on-time payments according to the Day School Contract signed at the time of enrollment. A \$50 Late Fee will be assessed for payments made after the 7th of the month. A child's enrollment may be discontinued if an account balance is more than 30-days past due.
